

How to use bulk promotion

Content

What is bulk promotion?

With bulk promotion users are able to change their acceptance indicator or dossier phase for more than one dossier in one step. With this handy feature doesn't have to go to the dossier details and change the light or the phase dossier by dossier.

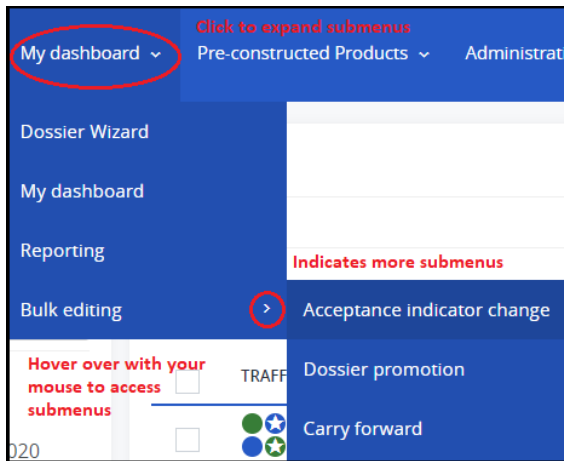
As it was written above there two types of bulk promotion:

- Acceptance indicator change: user can change his/her acceptance indicator to another color
- Dossier promotion: user promote dossiers to the next phase or can withdraw dossiers from a further phase

PCS is also doing promotion during the timetable process if the lights of the acceptance indicators are fine and there is a deadline in the process. For further details please check the PCS Process & Guidelines.

Where to find bulk promotion?

Bulk promotion is located under the "Dashboard" menu together with "My Dashboard", "Reporting" and "Bulk Editing".



Acceptance indicator change

After choosing the acceptance indicator change option the user will be lead to a search page that looks like and works almost the same way as the "Advanced search". There the user can search for the dossiers that he/she would like to edit.

When the user has the proper dossiers in the result, he/she can select them from the table with the checkboxes.

After the user selected the dossiers, the drop-down list will be enabled at the bottom of the screen, where the user can select the target light.

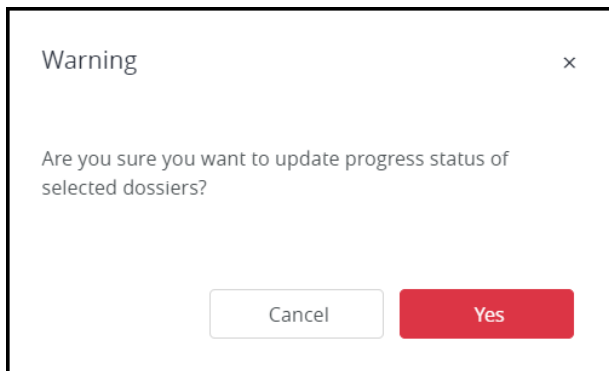

Once dossiers are selected the button becomes available

- Being processed
- Not accepted
- Accepted

Before applying the necessary changes the system sends a confirmation message from the user, whether he/she really wants to change the acceptance indicators of the selected dossiers.



Please note that the logic and the rules for the indicator changes are the same as in one dossier's control segment.

- User is not able to set back acceptance indicator to blue
- User is able to set green light to a dossier only if the mandatory times on the reference point and the mandatory parameters are fulfilled

The update is an asynchronous action, and the change is done in the background.

Dossier promotion

After choosing the dossier promotion option the user will be lead to a search page. There the user can search for the dossiers that he/she would like to promote. It also looks similar to the "Advanced search" page, however, it has a little bit different content.

Please note that the logic and the rules for the dossier promotion are the same as in one dossier's control segment.

- Leading Applicant User is not able to submit Path Request without green lights in all pair
- Leading IM/RFC User is not able to send Draft or Final offer without green lights in all pair
- Leading Applicant User is not able to go to Active Timetable without green lights in all pair
- Leading Applicant User can release Harmonization without green lights in all pair
- Leading IM User can release Path Elaboration without green lights in all pair
- Leading Applicant can release Post-Processing without green lights in all pair
- Leading Applicant can start Feasibility Study without green lights in all pair
- Leading Applicant can submit Feasibility Study Request without green lights in all pair
- Leading IM can send Feasibility Study result without green lights in all pair
- Leading Applicant can accept Feasibility Study result without green lights in all pair

The availability of the dossier promotion among the agencies (Applicant, IM, RFC, leading, involved) is the same as in dossier control.

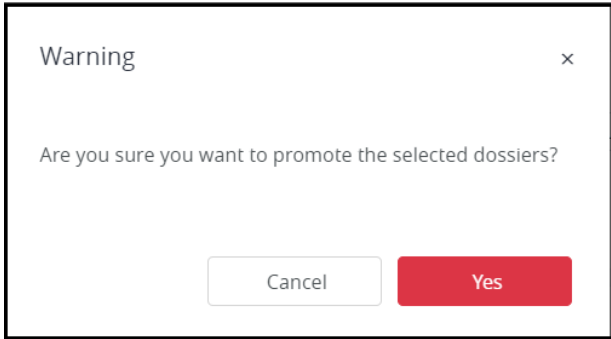
Target states

Please find here the target states that are available in PCS for the users. It is written in brackets to whom is available the particular action.

- Path Request Process
 - Harmonization (Applicant): dossiers that are in the Open phase
 - Withdraw dossier (Applicant): dossiers that are in Path Request or Path Elaboration phase. A mandatory comment is necessary the same as in Control
 - Path Request (Applicant): dossier that is in Harmonization
 - Reject dossier (IM/RFC): dossiers that are in Path Request or Path Elaboration. A mandatory comment is necessary the same as in Control
 - Path Elaboration (IM): dossiers that are in Path Request
 - Draft Timetable, Late Path Request Offer, Ad-hoc Path Request Offer (IM): dossiers that are in Path Elaboration
 - Switch to partial offer (Path Elaboration) (IM): dossiers that are in Path Elaboration. A mandatory comment is necessary the same as in Control
 - Observations (IM): dossiers that are in Path Elaboration
 - Post-processing (Applicant): dossiers that are in Observation
 - Final Offer (IM): dossiers that are in Post-Processing
 - Switch to partial offer (Post-processing) (IM): dossiers that are in Post-Processing. A mandatory comment is necessary the same as in Control
 - Active Timetable (Applicant): dossiers that are in Final Offer
 - Closed (Applicant, IM): dossiers that are in Active Timetable
- Feasibility Study
 - Harmonization Conference (Applicant): dossiers that are in Harmonization
 - Withdraw Path Study (Applicant): dossiers that are in Harmonization Conference, Feasibility Study Elaboration. A mandatory comment is necessary the same as in Control
 - Feasibility Study Request (Applicant): dossiers that are in Harmonization Conference
 - Feasibility Study Elaboration (IM): dossiers that are in Feasibility Study Request
 - Feasibility Elaboration Conference (IM): dossiers that are in Feasibility Study Elaboration
 - Feasibility Study Result (IM): dossiers that are in Feasibility Study Elaboration
 - Withdraw Path Study Result (IM): dossiers that are in Feasibility Study Result
 - Acknowledge Path Study Result (Applicant): dossiers that are in Feasibility Study Result
- Path Modification/Path Alteration
 - Path Modification Request (Applicant): dossiers that are in Path Modification Conference
 - Withdraw Path Modification (Applicant): dossiers that are in Path Modification Request, Path Modification Elaboration
 - Path Modification Elaboration (Applicant): dossiers that are in Path Modification Request
 - Path Modification Offer (IM): dossiers that are in Path Modification Elaboration
 - Reject Path Modification Offer (Applicant): dossiers that are in Path Modification Offer
 - Path Alteration Offer (IM): dossiers that are in Path Alteration Conference
 - Withdraw Path Alteration (IM): dossiers that are in Path Alteration Conference
 - Accept Path Alteration offer (Applicant): dossiers that are in Path Alteration Offer
 - Reject Path Alteration offer (Applicant): dossiers that are in Path Alteration Offer
- Pre-Arranged Path and Catalogues
 - Path Elaboration (PaP) (RFC): dossiers that are in Open (PaP)
 - Published (PaP) (IM/RFC): dossiers that are in Path Elaboration (PaP)
 - Closed (PaP) (IM/RFC): dossiers that are in Published (PaP)
 - Withdraw PaP catalog (IM/RFC): dossiers that are Published (PaP)
 - Path Elaboration (CT) (IM): dossiers that are in Open (CT)
 - Published (CT) (IM): dossiers that are in Path Elaboration (CT)
 - Closed (CT) (IM): dossiers that are in Published (CT)
 - Withdraw CT catalog (IM): dossiers that are in Published (CT)

Confirmation of dossier promotion

Dossier promotion is a higher level dossier editing than the acceptance indicator change, therefore, PCS asks for confirmation from the user, whether he/she really wants to change the phases of the selected dossiers.
